I understand that I am to remain in my booth for the entire event. I agree to have my space cleaned up after the event by 4:30 p.m. I understand that the registration fee is non-refundable. I understand that the Mt Pilchuck PTA does not guarantee any sale or bookings from the fair.

Dept of Revenue & County Health Dept Requirements: I certify that I am in compliance with all Washington State Department of Revenue sales tax requirements. If I am distributing food, it is my responsibility to be current on all food handling procedures and the county health department requirements.

Door Prize Item: I agree to donate an item of my choosing to be used as a Door Prize in the Door Prize Drawing to be held at the end of the Mt Pilchuck Holiday Vendor Bazaar.

Advertising: I understand that Mt Pilchuck Elementary PTA will advertise locally to the best of their ability. I will receive an event flyer via email and agree to promote the Mt Pilchuck Holiday Vendor Bazaar to my customer list, friends, and family.

Amenities & Venue: Each space includes the use of one chair at the event. I agree that if I need electricity to power my display, I will bring my own extension cord and I will submit my request for electricity by December 1st, 2016. The Mt Pilchuck PTA will do their best to place my table space near an outlet. I agree to bring an electrical cord and any other accessories as needed for my business. I agree to clean up my space prior to leaving. I will provide my own table for this event not to exceed 6'.

Registration Fee: The \$40 registration fee includes a folding chair within my vendor space and is due no later than December 1st, 2016. A \$5 discount will be given for registration fees received by the Mt Pilchuck PTA by November 18th, 2016.
